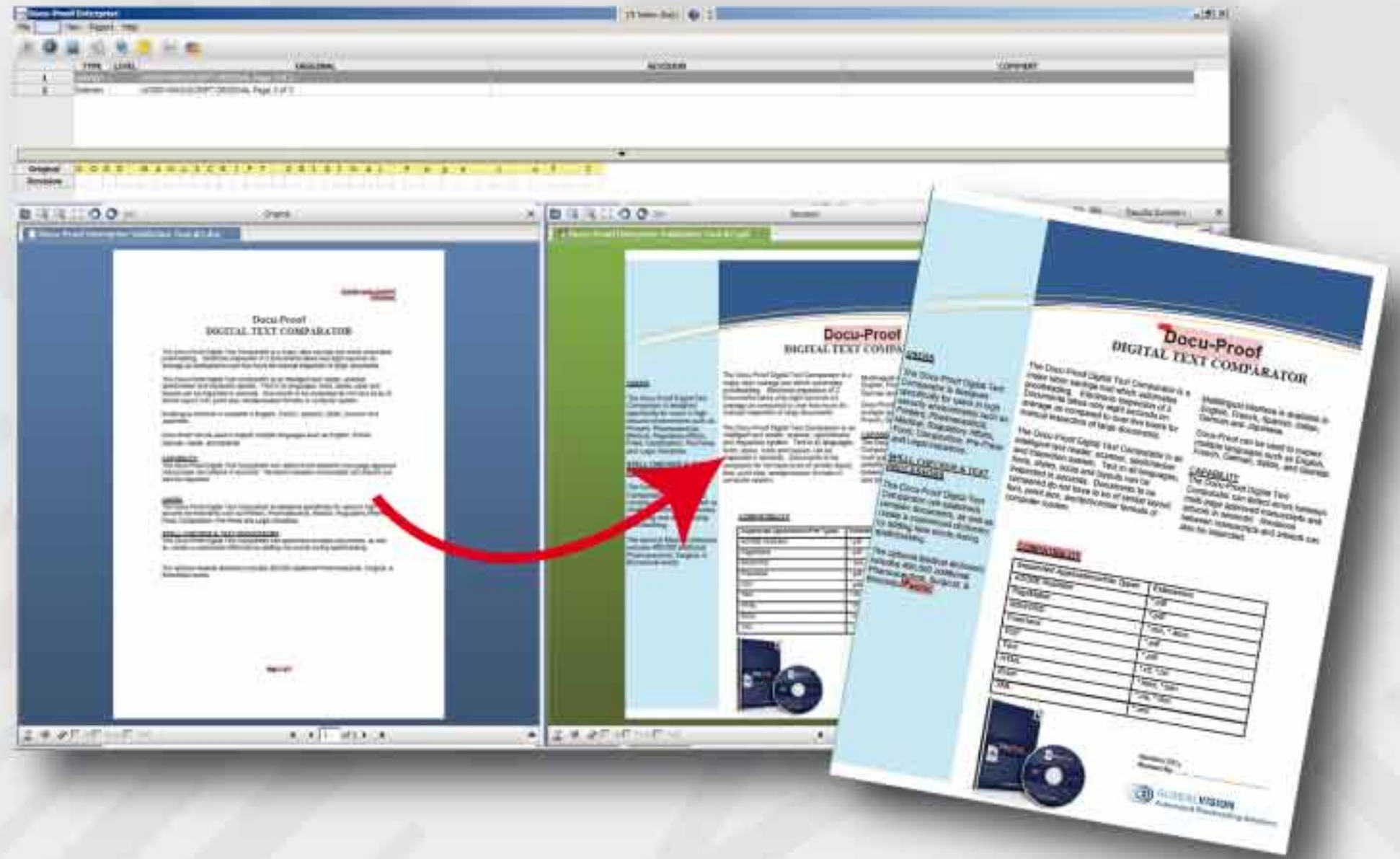

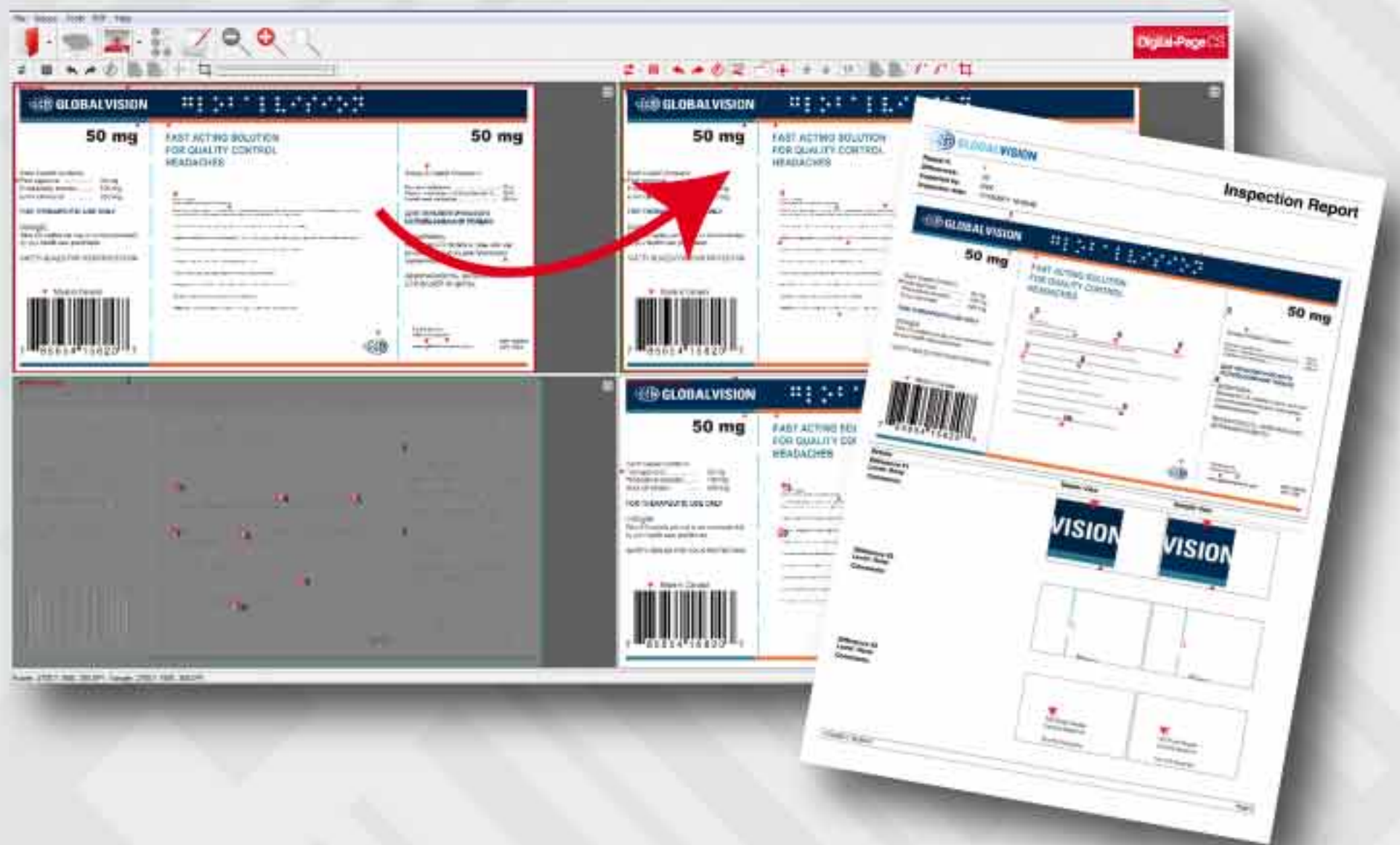

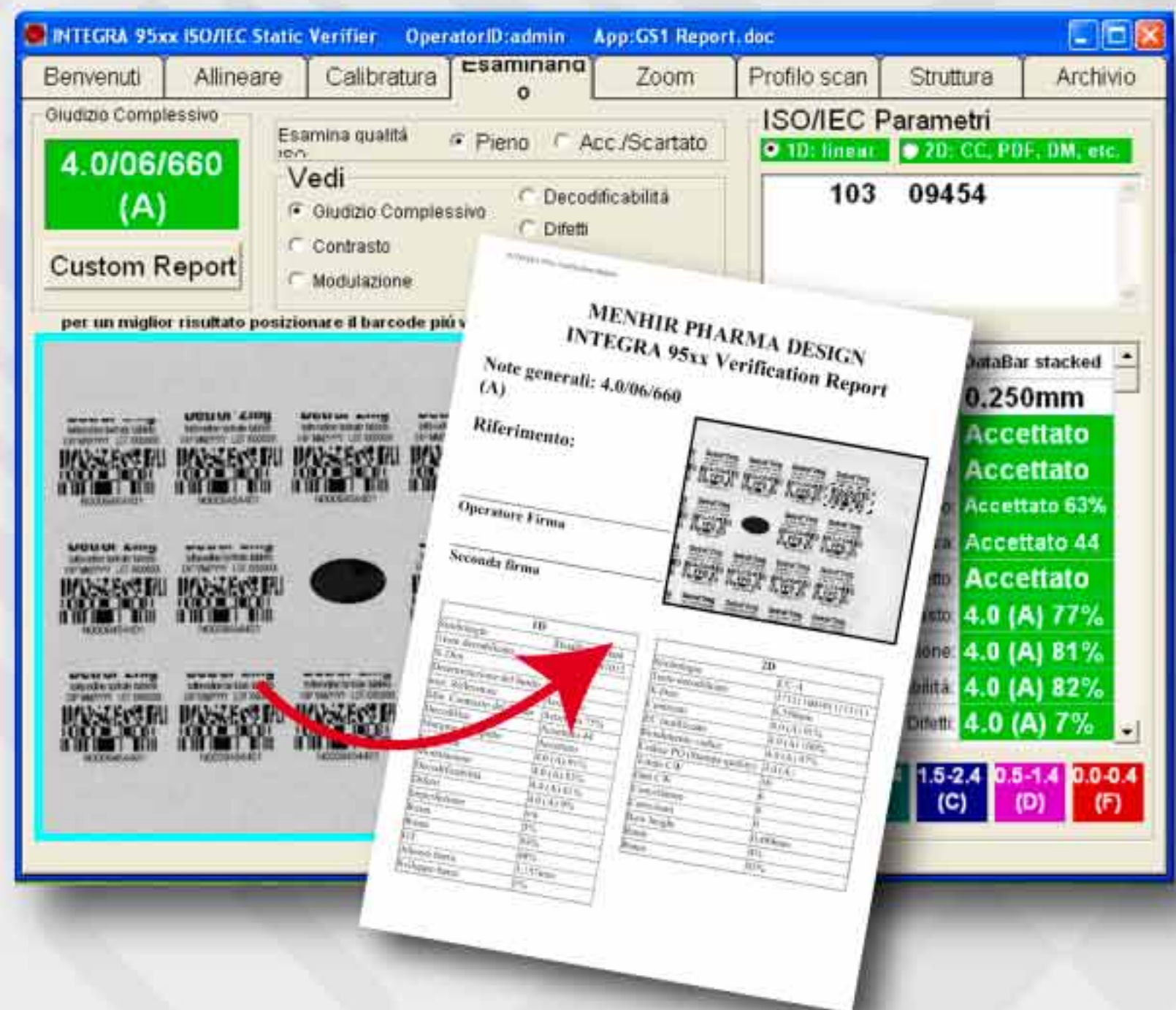
A barcode that cannot be scanned can cause snags in the distribution of a product.
